Searching by **case number** or **citation number** alone is the most efficient way to find a case. However, if you know any of the following cross reference numbers, you may also search by it as well.

- **UCN** - Uniform Case Number
- **BCCN** - Broward County Control Number
- **NTA** - Notice to Appear Number
- **BSO** - Broward Sheriff Office Arrest Number
- **SAO** - State Attorney Office Booking Number

You may search for up to 200 specific numbers (based on the number search type) at once. Separate multiple numbers by a comma.
